Parents or guardians of students living in the Rush-Henrietta Central School District and attending or planning to attend private or parochial schools, which are served by the Rush-Henrietta Transportation Department, must file a written request for 2017/2018 transportation by **April 1st**. Only residents of the Rush-Henrietta Central School District may access transportation for their child. Proof of residency may be required under certain circumstances.

- This request is for the 2017/2018 school year only and must be renewed each year.
- Please make the transportation request whether acceptance by the private or parochial school is certain or not at this time.

**Kindergarten students will be transported by the district only if the child is five years old before December 1, 2017. Kindergarten requests must be accompanied by a copy of a birth or baptismal certificate.**
